



ASSURANCE STATEMENT

NATURE AND SCOPE OF THE ASSURANCE/VERIFICATION

SGS United Kingdom Limited was commissioned by Reynolds American Inc. (RAI) to provide independent assurance of its Environmental Performance Indicators Report for the calendar year 2017. The scope of the engagement included assessment of the following Environmental Performance Indicators expressed on an absolute basis and also relative to production:

- Direct and Indirect energy consumption by primary source
- Total water withdrawal by source
- Total direct and indirect greenhouse gas emissions by weight
- NOx, SOx, and other significant air emissions by type and weight
- Total water discharge by quality and destination
- Total weight of waste by type and disposal method

The management of RAI is responsible for the selection, preparation and reporting of information included in its 2017 Environmental Performance Indicators Report. It is SGS' responsibility to express an independent opinion to stakeholders on the reported data within the scope of verification.

The objective of the engagement was to provide a limited level of assurance to RAI stakeholders that the reported indicators are:

- Accurate and free from material misstatement
- Reported in accordance with the Principles of the GRI Sustainability Reporting Guidelines (G3) for ensuring the quality and appropriate presentation of reported information and Indicator Protocols

The assurance and verification methodology employed by SGS are based upon internationally recognized standards and guidance, including ISO 14064-3: Specification with guidance for the validation and verification of greenhouse gas assertions, the Principles contained within the Global Reporting Initiative (GRI) Sustainability Reporting Guidelines for accuracy and reliability and the guidance on levels of assurance contained within the AA1000 series of standards and guidance for Assurance Providers. The assurance comprised a combination of site visits and interviews with relevant employees at Tobaccoville, Oxford and Winston-Salem, North Carolina, documentation, evidence and record review.

STATEMENT OF INDEPENDENCE AND COMPETENCE
